1. Deborah Atno-Shelton-Acting Chair called the meeting to order with roundtable introductions of all present.

2. **Affiliations:** Requests

Cedric Moore, Jr.-*Spectrum Transformation Group* presented a program request for affiliation He began with an introduction to the program which is the first provider licensed for autism services. His program tests individuals ages 5 years to 65 years old and has offices in Richmond and Harrisonburg. While still in development, the program plans to develop "step down" services from intensive in-home services. Mr. Moore stated that the program uses Crisis Prevention Institute for its staff training and has 3 psychologists. He emphasized that the use of restraint would be a last resort.

Gretchen Wilhelm, *Affiliate: Compass Y&F Svcs.* requested an expansion to provide EPSDT services, IHSS, and MH skill building services for Lexington, noting that an office location was yet to be determined.

Action: Motions were made and seconded regarding CCCA LHRC approval of the affiliation request made by Spectrum Transformation Group and the expansion of Compass Youth & Family Services as requested; the motion passed unanimously.
